

Shop And Win In Penfield

Official Rules

1. The promotion runs from January 1, 2010 through March 31, 2010.
2. All entries must be received by April 10, 2010.
3. Winners will be notified on April 14, 2010
4. To enter, a completed entry form, together with copies of three invoices from unique purchases made at any Penfield Chamber of Commerce member business, must be mailed to the Penfield Chamber addressed to: Shop And Win, Penfield Chamber of Commerce, P.O. Box 545, Penfield, NY 14526.
5. All receipts submitted with entry forms must be from purchases made between January 1, 2010 and March 31, 2010.
6. Individuals may enter as many times as they wish, provided each entry includes a separate entry form and three unique receipts. Receipts for the same purchase may not be submitted with more than one entry.
7. Cash prizes will be awarded in "Chamber Bucks" which can be spent like cash at any Penfield Chamber member business. Chamber bucks will be presented in denominations of \$5.00 and \$10.00. Chamber Bucks may not be used for purchases at businesses that are not members of the Penfield Chamber of Commerce.
8. No purchase is required. As an alternative to submitting copies of receipts for purchases made, no-purchase receipts may be submitted instead. No-purchase receipts will be available at participating Chamber member businesses. Anyone may obtain a no-purchase receipt by requesting one from a participating Penfield Chamber member business. A representative of the Chamber member business must fill out an official no-purchase receipt for anyone requesting one. They are limited to providing one per day per individual. The no-purchase receipts must include the date issued, the name of the Chamber member business and the name of the person issuing the no-purchase receipt.
9. Prizes will be drawn from all qualified entries received. First prize will be drawn first. The first prize will be \$350 in Chamber Bucks. The second prize will be drawn next. Second prize will be \$100 in Chamber Bucks. Third prize will be drawn next. Third prize will be \$50 in Chamber Bucks.
10. Additional prizes may be provided by Chamber member businesses. These must be in the form of gift certificates. All gift certificates must be a minimum of \$10.00 in value. Drawings for all additional prizes will be made following the first, second and third prize drawings.
11. All winners will be notified by email or telephone.
12. All winners will be listed on the Penfield Chamber website at PenfieldChamber.org
13. Redemption of Chamber Bucks must be made by making a purchase at a Penfield Chamber member business. The Chamber Bucks may only be used by the official winners. Chamber Bucks are not transferrable. The winner must present and ID and sign each Chamber Buck.
14. Penfield Chamber member businesses that receive Chamber Bucks as payment for a purchase, must ask to see the ID of the purchaser and confirm they are the person the Chamber Bucks

were issued to. They must make sure the winner signs each Chamber Buck before it is accepted as payment. The name of the business must also be written on each Chamber Buck. To redeem the Chamber Bucks received, the Penfield Chamber member business has to mail the redeemed Chamber Bucks to the Penfield Chamber at P.O Box 545, Penfield, NY 14526. A check for the face value of the Chamber Bucks received by the Penfield Chamber will be sent to the business that submits them. Checks will be sent within five days of receipt.

15. Chamber bucks can only be used to make purchases from current members of the Penfield Chamber of Commerce. Reimbursement will not be made to any business that is not a current member of the Penfield Chamber of Commerce.
